## Minutes Lawrence County School Board Meeting July 7, 2014

The Lawrence County Board of Directors met in regular session on Monday, July 7 in the board room of the Superintendent's office at 5:00p.m. Keith Brand was not in attendance.

President Terry Kelley called the meeting to order. John Householder offered the prayer.

Superintendent Belcher presented the June minutes for Board approval. Greg Gill moved to approve the minutes as presented. Joe Penn second the motion. The motion received unanimous approval.

President Kelley moved to the Superintendent's Report. The first item was Old Business. Superintendent Belcher informed the Board that the community center roof project was almost to completion. Mr. Belcher also informed the Board that the district moved \$92,657.44 from operating fund to the building fund to pay for the project. - Add Active Shooter Drill to the list of emergency procedures
- Add the Digital Learning Act (1280) in the list of graduation requirements beginning with the class of 2018
- Add a Video Surveillance statement
- Include the Academic requirements for participation in Extra-curricular activities for both Junior and Senior High
- To add a full year of Oral Communications to the requirements to be an honor graduate beginning with the class of 2018
- Must have an A average to be exempt from semester tests

Superintendent Belcher recommended these changes be added to the Walnut Ridge School 7-12 student handbook as well as the changes that pertain to the elementary handbook for the 2014-2015

school year. John Householder moved to approve the changes. Pat Roby second the motion. The motion received unanimous approval.
