The Lawrence County School Board of Directors met in regular session on Monday, September 18, 2013 in the board room at the Walnut Ridge campus at 5:00 p.m.

President Brand called the meeting to order and John Householder offered the prayer.

Terry Kelley moved to approve the minutes as presented. Pat Roby second the motion. The motion received unanimous approval.

President Brand moved to the Superintendent's Report. Superintendent Belcher informed the Board that covered walkways had been completed at the elementary and middle school buildings. Mr. Belcher also stated that Hickman's had completed the excavation of the house adjacent to the field house and that gravel had been applied to the lot.
