

JUNE 9, 2025 MINUTES

LAWRENCE COUNTY SCHOOL DISTRICT

The Lawrence County Board of Directors met in regular session on Monday, June 9, 2025, in the boardroom of the Superintendent's Office. Vice President, Pat Roby called the meeting to order and Vickie Mitchell offered the prayer.

Vice President Pat Roby requested a motion to authorize Jacob Kersey, the current high school principal and incoming superintendent, to act on behalf of the superintendent for the meeting due to Mr. Belcher's absence for medical reasons. Scott Brady moved to approve the authorization. Vickie Mitchell seconded the motion. The motion received unanimous approval.

MINUTES

Acting Superintendent Jacob Kersey presented the minutes of the regular May meeting and the Special May meeting for approval. Vickie Mitchell moved to approve the minutes of the board meeting as presented. Adam Davis seconded the motion. The motion received unanimous approval.

ELECTION OF OFFICERS

Acting Superintendent Jacob Kersey called for nominations for new board officers. Joe Penn moved to elect Brittany Farmer as President of the School Board for the 2025-2026 school year. Vickie Mitchell seconded the motion. The motion received unanimous approval.

Joe Penn moved to elect Adam Davis as Vice President. Scott Brady seconded the motion. The motion received unanimous approval.

Joe Penn moved to elect Kai Rorex Board Secretary. Pat Roby seconded the motion. The motion received unanimous approval.

Acting Superintendent Jacob Kersey stated to the Board that according to Act 671-2003 the Board must name one of its members as the primary dispersing officer. Mr. Kersey proposed Vickie Mitchell serve as the dispersing officer for the upcoming 2025-2026 school year. Joe Penn moved to approve Vickie Mitchell as the dispersing officer of the Lawrence County School Board. Pat Roby seconded the motion. The motion received unanimous approval.

Acting Superintendent Jacob Kersey moved to the Superintendent's Report. The first item was Old Business. Mr. Kersey updated the Board on the parking lot project and summer maintenance plans.

Annual nurse report was presented to the Board.

Acting Superintendent Jacob Kersey recommended the Board make the following changes to the 2025-2026 school year: Admin Assistant \$1500, Assistant Principal salary \$80,000, addition of Elementary Athletics Director \$2500. Adam Davis moved to approve the recommendation. Scott Brady seconded the motion. The motion received unanimous approval.
